## MINOR CONSENT for TATTOO/PIERCING

In the state of Florida and at [Fine Ink Studios](#), if you are under the age of 18 you must have your parent's or legal guardian's permission to get a tattoo or piercing.

### Tattoo:

It is against the law in Florida to tattoo any person under the age of 16 regardless of consent. If you are 16 or 17 years old your parent or legal guardian must be present when you are being tattooed and you must give us a notarized copy of the "[MinorConsentForm](#)". On the consent form your parent must state what design you will be getting tattooed and where on your body. You and your parent or legal guardian must also present a photo ID at the time of the tattoo.

### Piercing:

Anyone under the age of 18 must give us a notarized copy of the "[MinorConsentForm](#)". If you are under the age of 17 your parent or legal guardian must be present when you get your piercing. On the consent form your parent must state what kind of piercing and where on your body. Your parent or legal guardian must also present a copy of their photo ID at the time of the piercing.
